\_\_\_/LESI, In exercise of the powers (1997)-40/2014 5985 conferred by clause (d) of sub-section (I) of section 2 of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 (27 of 1996), the State Government do hereby specify the following categories of works as building and other construction works for the purposes of the said Act, namely:-

- 1. Cutting, breaking and crushing of stone.
- 2. Cutting and polishing of slabs or tiles.
- 3. Wood work including painting and varnishing.
- 4. Sewerage and plumbing work.
- 5. Electrical works including wiring, distribution and panel fixing
- 6. Installation and repair of firefighting systems.
- 7. Installation and repair of cooling and heating system.
  - 8. Installation of lifts and escalators.
  - 9. Installation of security gates.
  - 10. Fabrication and installation of iron or metal grills, windows and doors.
  - 11. Construction of water harvesting structures.
  - 12. Interior work including carpeting, false ceiling, lighting and plaster of paris.
  - 13. Cutting, glazing and installation of glass panels.
  - 14. Making of Bricks and roofing tiles, not covered under the Factories Act, 1948.
  - 15. Installation of energy efficient equipment like solar panels.
  - 16. Installation of modular units for use in places such as kitchens.
  - 17. Making and installation of pre-fabricated concrete modules.
  - 18. Construction of sports or recreation facilities including swimming pools and golf courses.
  - 19. Construction or erection of signage, road furniture, bus shelters or depots or stands and signaling system.
  - 20. Construction of rotaries and installation of fountains
  - 21. Construction of public parks, walking tracks and landscaping
