NOTIFICATION

- S.R.O. No. 231/2012—In exercise of the powers conferred by Section 62, read with Section 40 of the Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Act, 1996 (27 of 1996), the State Government after consultation with the Expert Committee, do hereby make the following rules further to amend the Odisha Building and Expert Construction Workers' (Regulation of Employment and Conditions of Service) Rules, 2002, Other Construction Workers' (Regulation of Employment and Conditions of Service) Rules, 2002, namely:—
- 1. (1) These rules may be called the Odisha Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Amendment Rules, 2012.
 - (2) They shall come into force on the date of their publication in the Odisha Gazette
- 2. In the Odisha Building and Other Construction Workers' (Regulation of Employment and Conditions of Service) Rules, 2002 (hereinafter referred to as the said rules), in Rule 262 (i) in Sub-rule (I), the figures 'Rs. 5000' shall be substituted by the figures, words and brackets "Rs. 25,000.00 (Rupees Twenty-five thousand) only".
 - (ii) After the sub-rule (3) the following sub-rule shall be inserted, namely: -- ,
 - "(4) The Board may also delegate financial powers to the District Labour Officers of the Labour Directorate to sanction and payment of medical expenses up to Rs. 5,000.00 (Rupees Five Thousand) only per month @ not exceeding Rs. 500.00 (Rupees Five Hundred) only per case exceptioneral and educational assistance to the beneficiary. In case, the District Labour Officers need to incur expenditure beyond the ceiling, same may be referred to the Board for further action."
 - 3. In the said Rule 270 in Rule (i) the letters and figures 'Rs. 50,000.00' and 'Rs. 25,000.00' appearing against items (A) and (B) respectively shall be substituted by the following, namely—'Rs. 75,000.00' and Rs. '40,000.00'.

"(E) The Board may sanction compensatory allowance @ 30% of the minimum wages for the construction workers covered under ESI Scheme for the period of treatment in Government and ESI empanelled hospitals subject to maximum up to 30 (thirty) days as 70% of the wages during the period of treatment are reimbursed by ESI Corporation.

Compensatory allowance @ minimum wages for the period of treatment subject to maximum up to 30 (thirty) days shall be reimbursed by workers not covered under ESI Scheme."

4. In the said rules, in Rule 271, in sub-rule (i), the figures and letters 'Rs. 25,000.00' and 'Rs. 50,000.00' shall respectively be substituted by the figures, letters, words and brackets 'Rs. 50,000.00 (Rupees Fifty Thousand)' and 'Rs. 1,00,000.00 (Rupees One Lakh)'.

5. In the said rules, for Rule 275, the following rule shall be substituted, namely:—

<u>"275—The Board shall grant financial assistance for education to the children of the beneficiaries having a continuous registration for a period of one year under the Board in the following manner.</u>

The children continuing their studies :-

- (i) 11th and 12th class—Rs. 1,500 for son and Rs. 2,000 for daughter per annum.
- (ii) B.A./B.Sc./B.Com. and ITI/Diploma—Rs. 2,000 for son and Rs. 2,500 for daughter per annum.
- (iii) For Engineering, Medical and P.G. studies—Rs. 3,000 per annum for both son and daughter.

The financial assistance for education to the beneficiary shall be entitled up to two children. In case both the spouses are registered beneficiary either of them will be eligible to get benefit of educational assistance."

- 6. In the said rules, in Rule 276, for the words 'Cancer, Heart Disease, Kidney Disease and Brain Disease, in Government Hospitals, the words 'Cancer, Heart Disease, Kidney Disease, Brain Disease, in Insulin-dependent and Thalesemia-cum-sickle cell', shall be substituted.
- 7. In the said rules, for Rule 277, the following rule shall be substituted, namely—"277". The maternity benefit @ Rs. 2,000 per child shall be given to the female beneficiary subject to maximum of two children who are registered beneficiaries for a period of one year. The Board may require such employees to submit application in Form XLI with such documents and within such time as may be specified by the Board.
- 8. In the said rules, in Rule 278, for sub-rule (2) the Para. shall be substituted by the following sub-rule, namely—"The Board may grant financial assistance up to Rs. 2,000 for purchase of working tools to the skilled and highly-skilled beneficiary, who are registered beneficiaries at least for a period of one year, subject to condition that they will produce purchase receipt of such items from the registered shop or company. The Board may require such employees to submit application in Form XLIV with such documents and within such time as may be specified by the Board".

9. In the said rules, after Rule 278-A, the following rule shall be inserted, namely :-

"278-B—The Board shall extend an amount of Rs. 5,000 (Rupees Five Thousand) only as marriage assistance to the unmarried beneficiary on her marriage and marriage of two girl children who are of above 18 years of age subject to minimum of one year as registered beneficiary. In case, both the spouses are registered beneficiary, either of them will be eligible to get benefit of marriage assistance. The Board may require such employees to submit application in Form XLV with such documents and within such time as may be specified by the Board."

10. In the said rules, the existing "Form XLI" shall be renamed as "Form XL" and after Form XL as so renamed, the following Form shall be inserted, namely:—
