Entract of 19th Board Meeting held on 25.04.2016.

Committees headed by CDMO of the district may be constituted by the District Collector alongwith one Surgery Specialist, one Medicine Specialist and the DLO for verifying the applications and the appended documents with the original documents available with the applicant and decision of the Committee thereon shall be final. The applicants may also be called upon for further verification. Accordingly, the decision may be communicated to the Board mentioning the specific amount of the benefit for sanction. In case of rejection, the DLOs will intimate the applicant about such rejection, with due intimation to the Board.

- b. All applications on marriage assistance pending at district level, without accompanied with the Marriage Certificate issued by the Competent Marriage Registering Authority can be approved on submission of Marriage Certificate issued by the Competent Authority or Self affidavit before the Executive Magistrate (only) by the applicant. The applicant may also be called upon for further verification. In case of rejection, the DLOs will intimate the applicant about such rejection.
- c. In case of re-imbursement of assistance towards working tools, safety equipment and bicycle purchased by the beneficiary, the beneficiary will be solely responsible for authenticity of the bill towards purchase of article. Under no circumstances, procurement of these articles will be done by the officers, henceforth. However, empanelment of registered wholesaler and /or distributor shops may be done at district level for purchase of these articles.
- d. All pending applications on other benefits may also be disposed of within 90 days after verification with the original documents.
- e. In case of detection of fraud on account of double receipt of assistance or receipt of assistance on the basis of fraudulent documents, the amount released towards any assistance may be recovered from the applicant under the provisions of OPDR Act and his/her membership may be ceased.

As direction of Ministry of Labour & Employment, Govt. of India issued u/s.60 of the B&OCW(RE&CS) Act vide letter No. Z-13011/03/2007-BL(Pt) Dtd. 08.10.2015 regarding formulation of different welfare schemes are mainly contributory schemes and are indicative, Board did not approve to implement these schemes for the time being. However, after protracted discussion, Board suggested for formulation of some new schemes as well as up-gradation of some existing schemes.
